MINOR WAIVER AND RELEASE OF LIABILITY

1. Waiver of Liability

By signing this Waiver and Release of Liability (Agreement), I, as the parent or legal guardian of a minor, waive and release Pacific Pines Golf & Social Club LLC, its agents, servants, employees, insurers, successors, and assigns from any and all claims, demands, causes of action, damages, or suits at law and equity of any kind, including but not limited to claims for personal injury, property damage, medical expenses, loss of services, on account of or in any way related to or growing out of my child's presence, participation, or involvement at the facility.

This waiver and release is intended to and does release Pacific Pines Golf & Social Club LLC from any and all liability for damages or injuries on account of or in any way related to or growing out of my child's negligence, the negligence of third parties, and Pacific Pines Golf & Social Club LLC's negligence. This is not intended to release Pacific Pines Golf & Social Club LLC from any liability resulting from their intentional conduct.

I further covenant and agree not to institute any claims or legal action against Pacific Pines Golf & Social Club LLC for any claim released by this Agreement. I further agree that should any claim be made against Pacific Pines Golf & Social Club LLC in contravention of this Agreement, including but not limited to derivative claims, I will protect, defend, and fully indemnify Pacific Pines Golf & Social Club LLC for any such claim and expenses, including attorney's fees and costs incurred by the club in defending themselves or securing indemnity hereunder.

2. Personal Property

Pacific Pines Golf & Social Club LLC is not responsible for any lost, stolen, or damaged valuables or property belonging to the minor.

3. Behavior and Supervision Policy

I understand and agree that my child must be supervised at all times while present at the facility. I agree that I am responsible for my child's behavior and actions while using the facility, including any damage caused to Pacific Pines Golf & Social Club LLC property or equipment.

4. Acknowledgment of Rules

I acknowledge that I have received and read a copy of the current rules and regulations

governing the use of the facility. I agree that my child and I will fully comply with all rules and regulations and with any amendments. I understand that failure to comply may result in the loss of access to the facility for my child.

5. Agreement and Acknowledgment

By signing below, I confirm that I have read, understand, and agree to the terms of this waiver and release of liability. I understand that by signing this Agreement, I am consenting to be bound by its terms, including waiving my legal right to sue Pacific Pines Golf & Social Club LLC for any costs they may incur due to a claim or legal action brought in violation of this Agreement. I agree that any violation of the Agreement and its terms and conditions, as determined by Pacific Pines Golf & Social Club LLC, will void and terminate this Agreement and may result in the loss of access to the facility for my child.
